Preface

What you can do with JP1/Automatic Job Management System 3

Computer-based operations performed on a daily basis typically include a large number of regular and routine tasks. For example, an enterprise might need to calculate daily sales data, prepare daily reports, produce monthly accounting summaries, or issue order entry forms. Many operations are not completed in a single step but entail a number of processes performed in a set order, or might require various conditions to be met.

By automating operations of this nature, costs can be reduced and valuable human resources can be freed up for more creative work. Automation allows the system to be run reliably with just a few operators.

JP1/Automatic Job Management System 3 (simply called JP1/AJS3 hereafter) is designed to automate routine applications.

By using JP1/AJS3 to define steps in an application and their order of execution, application processing can be performed automatically. JP1/AJS3 also allows you to define the application start time in advance or define applications that start when a specific event occurs, thus allowing you to automate complicated applications.

To automate an application by using JP1/AJS3, you need to identify each step in the application, and then define the execution order and hierarchical structure of the steps. Elements (or units) that make up an application are classified into three types: job, jobnet, and job group.

Defining the stone and their order of execution

Job:


The smallest unit of processing in JP1/AJS3. Processing of commands, application programs, or shell scripts can be defined as a job.

Jobnet:

A set of jobs with a defined execution order. Applications automated by JP1/AJS3 are executed in units of jobnets. *Job group*:

A folder for managing jobnets collectively. A job group can be created in another job group.

The following figure illustrates the hierarchy of units defined in JP1/AJS3.




What is explained in this manual

This manual explains the basic methods of configuring and operating JP1/AJS3. The purpose of this manual is to help readers briefly understand the basic usage of JP1/AJS3.

This manual is intended for the following persons:

- Those who are considering installing JP1/AJS3
- Those who want a brief overview of the process, from configuration to operation of JP1/AJS3.

The explanations in this manual assume that the system configuration shown below is used. For operations using other configurations, see the relevant JP1/AJS3 manuals.



JP1/AJS3 - Manager:

A program that stores jobnet definition information and execution schedule information, and manages the execution of jobnets. This program transfers jobs to be executed to JP1/AJS3 - Agent, and then receives information about the execution status and execution results.

JP1/AJS3 - Manager (which has the agent function for job execution control) also acts as the agent that executes jobs.

JP1/AJS3 - Web Console:

A program that has the functionality of both a web server and web application server. Upon receiving a request from a client, JP1/AJS3 - Web Console communicates with JP1/AJS3 - Manager, and then sends a response to the client.

Because JP1/AJS3 - Web Console has an interface for monitoring jobnets, any computer with a web browser can be used as a client via the Web GUI. Users can also create user applications that act as clients by using the API provided by JP1/AJS3.

JP1/AJS3 - Agent:

A program that executes jobs transferred from JP1/AJS3 - Manager.

JP1/AJS3 - View:

A program for operating JP1/AJS3 by using the GUI. JP1/AJS3 - View is connected to JP1/AJS3 - Manager to define jobnets, perform operations, and check the execution status.

JP1/Base:


A program that manages user permissions. JP1/Base is a prerequisite product for JP1/AJS3, and must be installed on a manager host on which JP1/AJS3 - Manager is installed and an agent host on which JP1/AJS3 - Agent is installed.

How to read this manual

There are 11 JP1/AJS3 manuals. This manual describes the procedure for setting up a JP1/AJS3 system (in Windows or Linux) and basic operations from JP1/AJS3 - View. This manual also describes how to monitor jobnets by using the Web GUI of JP1/AJS3 - Web Console.

For explanations about the configuration methods, the parts of this manual to be referenced depend on the OSs of the manager host and the agent host. See *1. Setting Up JP1/AJS3 (in Windows)* if the OS is Windows, and *2. Setting Up JP1/AJS3 (in Linux)* if the OS is Linux.

JP1/AJS3 also provides many other functions to implement many types of environments and operations. To learn about applied functions and operations according to the JP1/AJS3 installation and operation phases, see the relevant manuals other than Getting Started based on the following figure.

Explanations of operations in each window assume that the following environments are used.

Network environments:

Environment in which network communication is possible between the manager host, Web Console server, agent host, JP1/AJS3 - View host, and client, and each host name can be resolved.

Note that in an environment that uses a firewall, set the firewall so that communication via the ports used by JP1/AJS3 can pass through the firewall. For details about the direction in which communication passes through, see the JP1/Automatic Job Management System 3 System Design (Configuration) Guide in C.1 Related publications.

Operations on the manager host, Web Console server and agent host:

Environment in which Windows Server 2022 or Linux 9.1 is used

Operations on the JP1/AJS3 - View host:

Environment in which Windows 7 is used

Operations on the client:

Windows environment in which Microsoft Edge is used, or a Linux environment in which Firefox is used

Setting Up JP1/AJS3 (in Windows)

Before you can use JP1/AJS3 to automate routine or periodic tasks, set up a JP1/AJS3 system. This chapter describes how to install and set up JP1/AJS3 (Windows version).

1.1 General procedure for setting up JP1/AJS3

Install and set up JP1/AJS3 separately on a manager host, agent host, JP1/AJS3 - View host, and Web Console server.

The following figure shows the installation and setup procedures for each host.

This section describes the preparations required before installing JP1/AJS3 and its prerequisite product JP1/Base.

1.2.1 Memory and disk space required for installation

For details about the amount of memory and disk space that is required for installation, see the Release Notes.

1.2.2 Prerequisite language settings for OS

The language settings for the OS of the manager host, the agent host, the JP1/AJS3 - View host, and the Web Console server must be specified as the same language as that used in JP1/AJS3.

Make sure that **United States** is specified for the area setting, and **English** is specified for the language setting via the control panel of each host. If the language settings are incorrect, characters might be garbled, and definition data might be altered.

1.2.3 Background necessary for installation

This section describes the background necessary for installing JP1/Base and JP1/AJS3.

(1) About administrator privileges

In this manual, "administrator privileges" refer to the execution privileges of the built-in administrators of local PCs.

For the users who have administrator privileges for local PCs, operations do not vary in local user, domain user, and Active Directory environments.

Install and set up JP1/Base and JP1/AJS3 - Manager to configure the manager host.

Setting up JP1/Base on the manager host consists of the following four steps:

Setting up an authentication server:

An authentication server manages access permissions of JP1 users. Set up the server on which JP1/Base is installed as an authentication server.

Registering JP1 users in the authentication server:

Register JP1 users in the authentication server.

Setting operation permissions for JP1 users:

Set permissions (JP1 permission levels) that allow JP1 users to define and execute applications.


Setting user mapping:

User mapping is an operation to associate JP1 users with OS users on the host on which jobs are executed.

To execute a job in JP1/AJS3, a JP1 user accesses OS resources such as executable files by using permissions of an OS user associated with the JP1 user, and then performs processing. Therefore, the JP1 user must be associated with an OS user on the host on which the job is executed.

The following figure shows an overview of user mapping.





Note:

<User mapping definitions> in the figure indicates JP1-user-name:server-host-hame:OS-user name.

In this figure, the job executed by the JP1 user user01 on the JP1/AJS3 - View host is executed by the OS user MAN_OSuser on the manager host. If the job is transferred to the agent host, the job is executed by the OS user AGT_OSuser on the agent host.





Associate a JP1 user registered in the manager host to an OS user on the agent host so that the JP1 user can access OS resources on the agent host.

To execute a job in JP1/AJS3, a JP1 user accesses OS resources, such as executable files, by using permissions of an OS user associated with the JP1 user, and then performs processing. Therefore, the JP1 user must be associated with an OS user on the host on which the job is to be executed. This association is called *user mapping*.

The following figure shows an overview of user mapping.

In this figure, a job executed by the JP1 user user01 on the JP1/AJS3 - View host is executed by the OS user MAN_OSuser on the manager host. If the job is transferred to the agent host, the job is executed by the OS user AGT_OSuser on the agent host.

Setting up JP1/Base on the manager host consists of the following four steps:

Setting up an authentication server:

An authentication server manages access permissions of JP1 users. Set up the server on which JP1/Base is installed as an authentication server.

Registering JP1 users in the authentication server:

Register JP1 users in the authentication server.

Setting operation permissions for JP1 users:


Set permissions (JP1 permission levels) that allow JP1 users to define and execute applications.

Setting user mapping:

User mapping is an operation to associate JP1 users with OS users on the host on which jobs are executed.

To execute a job in JP1/AJS3, a JP1 user accesses OS resources such as executable files by using permissions of an OS user associated with the JP1 user, and then performs processing. Therefore, the JP1 user must be associated with an OS user on the host on which the job is executed.

The following figure shows an overview of user mapping.



Note:

<User mapping definitions> in the figure indicates JP1-user-name:server-host-hame:OS-user name.

In this figure, the job executed by the JP1 user user01 on the JP1/AJS3 - View host is executed by the OS user MAN_OSuser on the manager host. If the job is transferred to the agent host, the job is executed by the OS user AGT_OSuser on the agent host.







3.2 Basic configuration of the JP1/AJS3 - View main window

To define, execute, and monitor jobnets by using JP1/AJS3 - View, you need to display windows and dialog boxes appropriate for the purpose of operation, from the JP1/AJS3 - View window (Main window).

The following shows the JP1/AJS3 - View window (Main window).

Function menu area

Detailed information area

The following describes each area of the JP1/AJS3 - View window (Main window).

Function menu area

The function menus allow you to filter the items displayed in the list area, detailed information area, and operation menu according to the desired operation.

For example, if you select Cancel Registration, only the jobnets registered for execution are displayed in the list area so that only cancel registration can be performed. At this time, operation menus not relating to cancel registration are inactive, thus preventing incorrect operation.

Tree area

The tree area displays the job group defined for JP1/AJS3 - Manager in hierarchical format. When you select a unit in the tree area, the units immediately below the selected unit appear in the list area.

List area

The list area displays a list of units (job groups or jobnets) immediately below the job group selected in the tree area.

Detailed information area

The detailed information area displays the details, such as definitions and execution information, about the units selected in the list area. The displayed information varies depending on the selected function menus.

To display details, select a unit in the list area and then click the **Show** button. If you want to display the information for another unit, select a different unit in the list area and then click the Show button again.

3.3 Basic configuration of the Dashboard and the List screen of the Web GUI

To monitor a jobnet by using the Web GUI, use the Dashboard and List screens. Either screen can be selected from its tab at the top.

Configuration of the Dashboard screen

In the Dashboard screen, the progress of a selected jobnet and the number of units in each state can be monitored for a specific date.

4.4 Defining operation schedules

You can define the operation schedule of a jobnet to execute the jobnet only on holidays and specify the date and time to start execution of the jobnet.

Operation schedules you can define are classified into the following two types:

• Calendar information

Information about open days and closed days for jobnet execution. An open day is a day on which jobnets are executed. A closed day is a day on which jobnets are not executed.

Because the same open days and closed days often apply to multiple processes, calendar information is defined for a job group. The calendar information determines the days on which jobnets in the job group can be and cannot be executed.

• Schedule rule

Information such as the start time and processing cycle for a jobnet.

Because the start time and execution interval often vary depending on the application, schedule rules are set for jobnets.

4.4.1 Defining calendar information for a job group





The three types of methods for registering jobnets for execution are shown below. Select the method appropriate for the operation.

• Planned execution

The jobnet is executed according to the defined schedule. If you change the calendar or schedule after the jobnet is registered for execution, the schedule is immediately defined again so that the jobnet is executed based on the new schedule.

Fixed execution

The jobnet is executed according to the execution date and time calculated in advance based on the defined schedule.

Even if you change the calendar or schedule after the jobnet is registered for execution, the execution plan is not changed. Changes in the calendar and schedule will take effect after the next jobnet is registered for fixed execution.

Immediate execution

The jobnet is executed as soon as it is registered for execution. Calendars and schedules are invalidated, and execution starts for each execution registration.

If the jobnet is executed according to a predefined schedule (planned execution) and has a subsequent execution schedule, a status for which the next execution is being waited for, such as **Wait for start time**, is displayed. If the jobnet is executed immediately, **Not sched. to exe.** is displayed because no next execution schedule exists.

Result

Displays the execution results of the last executed jobnet.

3. Select **Operations**, and then **Rerun**.

The Generation Selection dialog box appears.

4. Select Result.



In the above dialog box, **Status** and **Result** indicate **Status** and **Result** columns in the list area in the JP1/AJS3 - View window (Main window).


^{7.} Correcting Jobnet Definitions and Re-Executing Jobnets

Select **Status** to re-register the jobnet that will be executed in planned execution. Select **Result** to re-execute the last executed jobnet. Because you need to re-execute the last executed jobnet, select **Result**.

5. Click the **OK** button.

The Rerun dialog box appears.

6. In **Rerun method**, select the unit from which to re-execute the jobnet.



7. Click the **OK** button.

The Rerun dialog box closes, and then the jobnet is re-executed.

8. Wait a while, and then select View, and then Refresh.

The list area in the JP1/AJS3 - View window (Main window) displays the re-execution results.

Result

The operation was restored by re-executing the jobnet that ended abnormally.


Appendixes

A. Advanced Use

This appendix outlines the functions for more efficient use of JP1/AJS3. For details, see the other manuals of JP1/AJS3. For details, see the manuals about JP1/AJS3 in *C.1 Related publications*.

A.1 Using a cluster system to improve system availability


Multiple server systems linked to operate as one system is called a *cluster system*. If an error occurs in the currently operating server, another standby server inherits applications and continues processing without interruption. Operating JP1/AJS3 in a cluster system prevents applications from being interrupted by server errors, thus improving availability of the application system.



A.2 Using the disaster recovery function for large-scale disaster management

Disaster recovery refers to measures that are taken for unexpected events such as system shutdown caused by a large-scale disaster.

Normally, JP1/AJS3 information stored in the shared disk is copied to the shared disk of the system provided at a remote site. In the case of an emergency, such as a disaster, operation is switched over to the system on the remote site, and the applications are resumed there. Using the disaster recovery function prevents applications from being interrupted by a disaster, thus improving availability of the application system.




Use the disk copy and mirroring functionality in the hardware to copy data between shared disks. This is not a function of JP1/AJS3.

A.3 Executing jobnets triggered by the occurrence of a specific event

In addition to executing a jobnet at the specified execution start time, you can execute a jobnet when a specific condition is met. You can specify this condition by using an event job (a JP1/AJS3 job) or start condition.

By using an event job or start condition, you can specify many types of conditions, such as creation, update, or deletion of a file, occurrence of a Windows event, and expiration of time. For example, you can define a process that starts a jobnet when file creation is detected, and a process that performs recovery ten minutes after an application ends abnormally.



A.4 Outputting jobnet schedule information and definition information in a desired format (JP1/AJS3 - Print Option)


JP1/AJS3 - Print Option, which is a JP1/AJS3 component, allows you to output jobnet schedule information, definition information, and execution schedule and result information as a form. You can also customize the output contents and format according to your purpose.

This function is effective if you want to check jobnet information in a document when, for example, you create an operation report for applications or check the results of correcting many jobnets.

Output of relation-line information for units in a map format




Output of schedule and execution result information for units in a daily format

A.5 Using Excel to edit unit definitions in a batch (JP1/AJS3 - Definition Assistant)

JP1/AJS3 - Definition Assistant[#] is an Excel template for editing schedule information and detailed definition information for units. JP1/AJS3 - Definition Assistant allows you to import and edit unit definition information registered in JP1/AJS3 to an Excel template, and register (export) the edited definition information to JP1/AJS3 as a batch.

You can edit information by using Excel commands such as copy, paste, search, and replace. This enables efficient development and operation. This function is effective if a large number of unit definitions are required in cases such as server migration or upgrading.



A.6 Establishing linkage with business tasks using cloud service (JP1/ AJS3 for Cloud Service Applications)

JP1/AJS3 for Cloud Service Applications[#] facilitates linkage between JP1/AJS3 and cloud services.

JP1/AJS3 for Cloud Service Applications consolidates and manages authentication information, execution information, and all the other information necessary to establish linkage with cloud services. By using this management information, you can create a custom job that performs a series of processes consisting of authentication, execution, and results verification, and then incorporate the custom job into a job flow in JP1/AJS3.

JP1/AJS3 can be used to centrally manage existing core business tasks and other business tasks that have been transferred to and are controlled by cloud systems.



#: JP1/AJS3 for Cloud Service Applications is an option product for JP1/AJS3.



C.10 Regular expressions available in JP1/AJS3

Regular expressions can be used in some items in dialog boxes and commands. For details about regular expressions in Windows, see the *JP1/Base User's Guide*. For details about regular expressions in UNIX, see your UNIX documentation.

The regular expressions that you can use when executing an event job on a Windows host depend on the JP1/Base settings. For details on setting regular expressions for event job execution, see the explanation about extending the available regular expressions in the *JP1/Base User's Guide*.

Searching may take a long time if you often use the regular expression . * (which means match any character or characters). In long messages, use . * only where necessary. In UNIX, you can use $[^{^{^{^{^{^{^{^{^{^{^{*}}}}}}}}}] *$ (repeat characters other than space characters) instead of . * when you want to find a match other than space characters. Using $[^{^{^{^{^{^{*}}}}}] *$ reduces the search time.

C.11 About the 3rd level and 4th level Kanji characters added in JIS 2004 (JIS X 0213:2004)

JP1/AJS3 cannot use the 3rd level and 4th level Kanji characters added in JIS 2004. If these characters are used, operation might not be performed correctly.

abnormal end

A jobnet ends abnormally if one of the processes defined in the jobnet fails to execute properly. The jobnet is interrupted at that point and subsequent processes are not executed.

A job ends abnormally if it fails to execute properly. The process is interrupted at that point.

agent host

A host that executes jobs on request from a manager host. JP1/AJS3 - Agent must be installed on the agent host, or since JP1/AJS3 - Manager also provides JP1/AJS3 - Agent functionality, JP1/AJS3 - Manager might be installed on the agent host.

The agent host executes the job on receipt of a job request from the manager host. At completion of the job, the agent host receives the execution result (return value) of the executable file and forwards it to the manager host.

calendar information

Information about open days and closed days for jobnet execution. You can define calendar information separately for each job group. The calendar information specifies the days on which jobnets in the job group can and cannot be executed. (When the processing cycle falls on a closed day, the jobnet can be executed on another day if a substitute schedule is defined.)

For open days, you can specify the base day, base month, and base time.

closed day

A day on which jobnets are not executed. However, if Execute without shift is specified, the jobnet will be executed on that closed day.

Daily Schedule window

A window that displays each day's execution schedules, execution status, and execution results.

fixed execution registration

A method of registering a jobnet so that it starts and runs at a predetermined date and time calculated by the system from schedule definitions.

immediate execution registration

A method for starting and processing a jobnet immediately after registering it for execution.

job

A group of commands, shell scripts, or Windows executable files.

job group

A folder for classifying and managing jobnets.

jobnet

A set of jobs associated in execution order. When a jobnet is executed, the jobs in the jobnet are automatically executed in their predetermined order.

Jobnet Editor window

A window in which you can create new jobnets or edit existing jobnets.

Jobnet Monitor window

A window that displays the execution status or detailed execution results of jobnets or jobs. You can manipulate jobnets or jobs in this window.

JP1 permission level

A name that indicates the operations that a JP1 user is allowed to perform on management targets (resources) defined in JP1/AJS3, including applications and events. Use JP1/Base to define JP1 permission levels.

JP1 resource group

A name given to a specific JP1/AJS3 unit for controlling access by JP1 users to that unit.

JP1 user

A user designation for using JP1/AJS3 or JP1/IM - Manager. Each JP1 user is registered in the authentication server, which controls the user's access to management targets (resources).

JP1/Base

JP1/Base is a prerequisite program for JP1/IM and JP1/AJS3. When a system that uses JP1/IM and JP1/AJS3 is installed, operation permissions (JP1 permission levels) can be set for JP1 users.

manager host

The manager host creates jobnet execution schedules from the defined schedule information. At jobnet run time, the manager host starts the executable files defined as jobs, forwards the job definitions to an agent host, and requests the agent host to execute the jobs. When execution completes, the execution result is received by the agent host and the database is updated. Based on the updated information, the manager host executes a succeeding job or schedules the next execution of the jobnet.

maximum number of concurrently executable jobs

The maximum number of jobs that can be executed concurrently.

Monthly Schedule window

A window that displays each month's execution schedules and execution results.

nested jobnet

A jobnet defined within another jobnet.

normal end

A normal end of a jobnet occurs when all the processes defined in the jobnet have executed correctly and the jobnet has completed.

A normal end of a job occurs when the job has executed correctly.

open day

A day when jobnets run.

planned execution registration

A method of registering a jobnet so that it starts and executes according to schedule definitions.

schedule rule

Jobnet information such as execution start time and processing cycle. Up to 144 schedule rules can be defined for a single jobnet.

unit

A generic term for any job network element.

Web GUI

An interface that uses a web browser to monitor units that are defined on the manager host. Web GUI connects to the Web Console server via a network such as the Internet. With Web GUI, you can monitor the execution status and result of jobnets, and execute and operate jobnets.
